This research explores the correlation between church ministry discipline based on Proverbs 10:17 and church growth in Kadosh Church, Palu. Using a theological approach and descriptive method, this study shows that discipline, including spiritual commitment, punctuality, and ministry management, has a significant influence on the spiritual health and growth of the congregation, both quantitatively and qualitatively. The findings of this study provide a foundation for the development of more effective ministry strategies.

GKB Kadosh Palu, as an influential church in the city of Palu, Indonesia, faces challenges in effectively implementing and maintaining discipline. As a growing community, the church realises that the discipline of its ministers directly affects the spiritual health of the congregation and the effectiveness of the ministry. Thus, this study aims to examine the correlation between the discipline of church ministers based on

Proverbs 10:17 and congregational growth at Kadosh Church in Palu. This research is expected to provide deep insight into the relationship between the discipline of church servants and church growth. By understanding the factors that influence discipline, churches can formulate more effective strategies in pastoring. The results of this study will not only benefit Kadosh Church in Palu, but can also serve as a reference for other churches in improving the quality of their ministries.

4. CONCLUSION
